H & W	The Employer contributes	Varies	Review the TeleData Collective Bargaining Agreement for the agreed amount per hour <u>paid</u> for each employee
Pension	The Employer contributes	Varies	Review the TeleData Collective Bargaining Agreement for the agreed amount per hour worked for each employee
HRA	The Employer contributes	Varies	Review the TeleData Collective Bargaining Agreement for the agreed amount per hour paid for each employee
NEBF	The Employer contributes	3%	of gross payroll to National Electrical Benefit Fund; a retirement benefit based on years of service
NEAP	The Employer contributes	Varies	Review the TeleData Collective Bargaining Agreement for the agreed amount per hour worked to National Electrical Annuity Plan
LMCC/NLMCC	The Employer contributes	\$0.11	per hour worked to the LMCC/NLMCC funds which are used for the advancement of the Union electrical industry.
CECAF	The Employer contributes	\$0.12	per hour worked to Cincinnati Electrical Contractors Association Fund
JATC	The Employer contributes	1.9%	of gross payroll to the Joint Apprenticeship and Training Committee for apprentices and journeymen training
Working Dues	The Employer deducts	5%	of weekly gross payroll is from union members only.
Credit Union	Voluntary deduction	Employee Choice	optional voluntary deduction from employee's paycheck, deposited into the DECA Credit Union.
Cope	Voluntary deduction	\$0.05	per hour worked will be deducted from paycheck to finance the Committee on Political Education.
